The subject is a slightly irregular shape inside the parcel, having a longer boundary along the street frontage and shorter rear boundary. It is slightly lower than the Boroko Drive frontage and gently slopes towards the southern or the rear boundary but generally level throughout and contains a total land area of 2, 099 square metres.
